Legislative Referral request: Transparency for AS STAR Account

Purpose: To recommend transparency regarding the AS STAR Account.

Title of Recommendation: AS STAR Account Transparency

Recommendation/Action: We recommend that the Chair of Finance, in accordance with the A.S. Marketing Department, work collaboratively to create a video to inform students of the A.S. Star Account's funding process. We also recommend that this video be updated annually. The STAR account's purpose is to fund student academic projects and research. This video can be sent out to clubs and organizations through the MIC database, the Red Hot News, and can be publicized by the Sundial. We also recommend that the Funding page, located under the Services tab, on the A.S. website be updated to better explain the account, what it funds, and how students can apply. Efforts are being made to keep students updated and informed of the A.S. STAR Account.
