- **A.** Chief Justice A. Zverev One amendment is to remove the chief justice as a nonvoting member from the fall elections committee meetings. The code amendment ensures that due process is followed in planning and creation of elections events.
- **B.** Chair of Elections D. Vicente– The amendments have been worked on for quite a while by the elections committee. It is the synthesis of the 4 previous elections codes. There are no amendments which may conflict with the integrity of the upcoming elections, and as your appointed chair of elections I ask that you approve the amendments put forth.
- C. Advisor L. Vincent regarding the Chief Justice not sitting as part of the elections planning process: As a company, our judiciary acts as our defense, in our favor. Combination of the chief justice position with the elections process which he later oversees, would express bias toward our organization. The less connected the judiciary and the elections committee, the less likely a decision made by the judiciary would be contested.
- **D.** Assistant Chair of Elections this code was reviewed and approved by you (the senators) last semester. During the elections meeting last week there was a code

change that was not approved regarding the candidates mandatory workshop attendance.

E. General Manager - though bias *may* be avoidable in entirety, the perception of bias is much more likely to be misinterpreted. These proposed changes support the public perception that there is nor will be any bias in our elections and judiciary.
