- ii. Improving Department Tutoring Centers (Senator Nguyen, Czarnecka, & Murali) **Nyguen:** talked to VP to seek guidance, went to dean's office and was directed to tutoring center, found master list of all tutoring services/classes, most tutoring goes to third enrollment students over the summer, 10 to 1 ratio, major problem, asst. dean thinks it's an issue as well, main issues is finding tutor, all they can do is posting that they need tutors, maybe need help with spreading word that tutoring is needed, advertising, talk to office itself, given budget for COBAE, don't go through AS Marketing, look at other marketing opportunites, maybe summer job as a tutor, continue talking to dean, look at extending tutoring hours **Czarnecka**: emailed dept. chair of Chem dept.; no response, will go to chair's office hours during her office hours **Murali**: working for math dept, went to tutoring center and got feedback from students working there, referred to Andrea chair of tutoring center, told her that they had everything covered, that their program was fine, contradictory to student feedback, lower division students crowd tutoring centers, chair of dept. emailed, didn't respond, forwarded email to Andrea, asked for face to face meeting with dean, said can meet with asst. dean, apt with Zahrra for 2:00pm 9/15 with Andrea feed back from Sen. **Czarnecka** who is a student in that dept., have good number of tutors but not all of them are equipped with the appropriate knowledge to help all the students there
- iii. Financial Literacy Refreshers (**Senator Martinez**) financial literacy program starts by having presentation in UNIV100 classes, informs them about budgeting CC debt, credit classes, want to introduce this presentation to older students, or have more opportunities for students to come in for the refresher courses, does not have contact into, will work on using Marilyn Magram Center
