Take Official Stance on EO 1100 & 1110 – **Senator Canas & Nguyen** – CSUN is the only CSU with a section F, and campus has large enrollment in these classes, concern is that if you cant take these classes as part of general ed then that means less exposure to these department which means less classes and eventually budgetary cuts to these departments; student action group is planning something in response, potential for marches, or campus boycotts, we should want to work together with administration, not hurt them, need to fight chancellor, not administration, we need to redirect anger and energy towards chancellor not each other, hoping that faculty senate votes for the delay instead of the freeze which will give us time to come up with and implement a plan to save the classes, if it freezes then the fate of these departments will be left to the chancellor
