- A. Sharon Aronoff (Klotz Health Center)
- AS is always welcome to ask for her assistance.
  - A flyer with services, doctors, and appointment instructions was provided.
  - Advanced Directive card given
  - National College Health Assessment: CSU-wide mandate to assess student health beliefs, behaviors, and values. Used to better serve the needs of our students. Oasis is a direct result of this assessment. Running through March 6. Information available under Health Promotion tab on SHC site.
  - Marketing for SHC goes across campus and starts with student leaders – NSO, UA, RA, etc. Primarily aimed at new students. All orientations are given the SHC information through panel discussions and tabling. U100 classes learn to be a “health care consumer.” “Perceived need” is where students tend to neglect the knowledge and resourcefulness of Klotz – this is where the marketing is aimed. Media outreach includes Sundial, Facebook page, main website. Tours seem to be the most successful element.
  - AS student leaders can promote SHC services. Have conversations. Discussion of a tab (either through the university or AS) that incorporates all of the wellness “package” – SHC, SRC, Oasis, etc. Discussion of adding a section in the annual planner called “Health and Wellness.” Suggestion for an ad in the Sundial where AS usually publicizes: use one week to have health services listed. Suggestion for a social media post regarding health issues (e.g., flu season) to encourage students to use the SHC.

#### II. Gender Neutral Restrooms

- I. Ramirez found that students are in favor of this, especially those in LGBTQ community
- Administration, faculty and staff have reservations about having non-ceiling-to-floor restrooms
- I. Ramirez suggested having an AS ballot question regarding this matter. S. Simonds will work with I. Ramirez and the Pride Center on this verbage.
- AS should push for one bathroom per building to be a “family” restroom – we don’t want a “gender inclusive” restroom with multiple stalls; just one that accommodates this need along with students with children and community members who are differently abled. Resolution is a must.

#### III. Enhancing Accessibility on Campus

- C. Turner went to the meeting with Ken Rosenthal. Findings included: elevators in Oviatt are being replaced, all buildings have elevators, accessibility buttons (for doors) are \$30K and not required by code, elevator signage may be the root of the problem
- Are we as accessible as we think? Try getting into rooms without use of your arms or hands. Let’s see what other challenges are not being addressed.
- For next meeting, let’s arrange for Ken and Jodi (DRES) to come and see how people who are differently abled are impacted by a current lack of accessible tech and access on campus.

#### IV. “One-Card” for Cross-Campus Improvement

- A. Crooks has reached out to San Marcos, Pomona, and LA
- D. Blunt provided a possible ballot question; it was amended to define the “small fee” mentioned: Would you be interested in a multi-purpose keycard that combines to act as a CSUN id, meal plan card, and dorm room key for a small fee of \$20 or less?

- Resolution to come: let's start work on this now. Draft for next week requested
